#### **Comments Regarding TCO's Financial Status**

Your Board is concerned about the financial state of the Trails Club. After a prolonged discussion, we passed a budget this month with projected expenses that are nearly double the projected income. Two-thirds of the expenses are fixed or necessary expenditures such as insurance, property taxes, tax preparation, state income tax, licenses and permits, internet fees, work trip meals, building and equipment repair/replacement, fuel, water and electricity. Some of these costs, especially insurance, have increased significantly in recent years. We really do not have too many expenses to cut.

We are currently able to cover the deficit with interest from our investment fund, but we are approaching the limit that is available. We desperately need to increase income and membership by holding more activities and events. Our lodges make TCO unique among our area's outdoor organizations. By completing the fire recovery at Nesika and updating Tyee to make it more comfortable, we should be able to capitalize on their attraction.

Our club is 107 years old. If we want to continue its legacy for those who come after us, each one of us needs to consider what we can do to make TCO more viable by inviting friends to participate in club activities, visiting the lodges when possible, organizing hikes, seminars, or any fun activity, and inviting friends and other family members to join.

#### Tyee Report, Paul

Compared to last year, winter came early, then stopped. The snow depth is about four feet at the Lodge. The frozen and burst shower pipe problem has been completed, including painting. The lodge was open every weekend in January except one and is scheduled to be open every weekend in February, including a nine day stretch over President's weekend. Paul gives a big thanks to the winter hosts: Nathan, Sheryl, Olivia and Loriann and Linda. The lodge openings would not have happened without them. There is quite a camaraderie among this group, constantly throwing ideas out for debate and decision making. The "Kids are Free Weekend" was fun. Children and adults enjoyed indoor and outdoor activities. Thank you Linda and Beverly. Glen and Paul even tubed the full length of the sled run. Insurance inspection which include pictures of the roof may well have to be postponed until after the snow clears.

#### Social Report, David via email

Goals from the Social Chair:

   Offer outdoor events that allow for social distancing and require masks, unless people are eating. — Follow State COVID mandates at events.
- Include as many volunteers as possible in the planning and execution of the events by reaching out in the planning phase one to three months prior.

Update on Diversity, Equity and Inclusion Outreach Activities, Julia Mace via email TCO continues to collaborate with the Sierra Club's Inspiring Connections Outdoors program and its partners to expand outdoor activities for youth. Chris Seubert has been a co-leader on three of the monthly hikes for youth in the Janus Youth Program. Monthly hikes are planned through December this year. It is possible that this may expand to include some additional monthly hikes later in the year. We have made efforts to offer other youth groups access to the TCO lodges. Several Boy Scout troops are scheduled to stay overnight at the Tyee in the coming months, and Sheryl Wagner hosted a youth group at the lodge in December.

Chris is working to set up day use events at our lodges for 2 Portland youth homes. Also, the

organization, People of Color Outdoors, is interested in using the lodges.

### NEW BUSINESS Budget

We looked at the budget line by line. The budget was approved with 8 in favor and 1 abstention. Our projected budget is nearly \$20,000 more than our projected income. After a prolonged discussion, we decided to post a statement in the Blazer about the Board's concern.

#### Reminders

For activities such as bicycle, snowshoe, and XC skiing check with the leaders for the difficulty level. Good equipment for the specific activity is required for all events. For hikes, snowshoes:

**Class A** - Shorter, less strenuous activity, typically 4 to 8 miles, less than 1500 feet elevation gain.

**Class B** - Moderate to difficult, typically 6 to 12 miles, up to 3000 feet of elevation gain.

**Class C** - Long and difficult, strong experienced participants only, typically over 8 miles, and over 3000 feet of elevation gain. Boots are recommended for B/C hikes.

Harsh or unusual conditions may greatly increase the exertion and skill required. Be prepared for the level of activity you are planning to take. Contact the trip leader if you have any questions and to let him or her know that you will be attending. Bring plenty of water and a sack lunch. Please, no alcohol. Remember to bring your Ten Essentials. Pets allowed on designated trips only.

Stay with the group and follow the leader. The leader is responsible for the group's safety. The leader determines which route is taken. The leader has authority to determine if a participant is prepared for the activity. Group safety must come first.

#### **Fees**

There is no charge to Trails Club members for day activities; nonmembers pay \$2. Please contribute to any carpooling expenses at the rate of \$.15 per mile. With multiple riders the driver can collect up to \$.30 per mile shared by all the riders. Other fees may apply. If you have RSVP'd for an activity at a lodge involving food expense and are unable to participate, you are obligated to do one of the following: Cancel before the food is purchased, find someone to take your place, or pay for your share of the food.

All activities must be approved by the appropriate activity Coordinator or the Trips Trustee.
