Paul

1a. Trees at Tyee: I was hoping that we would be able to take all 4 trees down "in house' but I have been told, one will probably need a climber, the 2nd has a crack midway. Mike Haasken has advised me to get a professional. I met with a Steve Cuthbert (sp) from Welches to discuss price and feasibility of getting these 2 trees down, He quoted \$750 for both. This is to drop them, TCO will buck the log. The dead tree has a crack through middle, and woodpeckers have pecked away a left a sliver 30 ft up. So the plan is to drop one tree and attempt to hit the second. Forest is at caution 4 now, no saws until heavy rains. The second estimate cannot make it here until October. He is from Bend. Here is the dilemma though, I transferred the tree removal money to the dorm upgrades, which I have no regrets. How much, if any is my approval for additional money for this project? Linda added, "If we have difficult trees we call Forest Service and they remove the tree. It is their land and their liability."

Risk: larger tree could take down fire escape and a piece of the Lodge if it comes down. Smaller tree is away from the Lodge, it could snap and fall on ground.

Glen will ask Forest Service Duty Supervisor, "We have two trees that 'should' come down at Tyee – do they know if there's a cutting crew in the Mt Hood National Forest?" Will find out this week and let Paul know.

Glen will give Paul names of two additional tree crews for estimates

If there is no cutting crew, what do we do? Decision is deferred until next month.

1b. I request that the lodge events for November (one Nesika, two Tyee) that we we scheduled before the fee increase was passed, be billed at the old rate, as the Boy Scouts were quoted the old rate and have paid their deposit. Jennifer moved to approve, Glen seconded, unanimous.

1c. Sheryl Wagner requested a weekend (it's on the calendar) at Tyee in Dec for her church group. In the by-laws it quotes "contact vice-president for board approval." Do I have the authority to say yes as it's from a known and trusted host?

Anyone wanting to make a reservation – contact Lodge chair, who will recommend to board for approval.

2. Linda: proposed bylaw change, see below Nominating:

Maybe we should make TCO positions more favorable by offering free membership for Trustees while they are serving on the board Consensus: no (no vote)

Lifetime membership for anyone serving over six years. May need to change a Bylaw: propose new language?

Consensus: not as policy. Subsequent board can vote to offer a departing board member a lifetime or one-year membership as a thank-vou.

Reminders

For activities such as bicycle, snowshoe, and XC skiing check with the leaders for the difficulty level. Good equipment for the specific activity is required for all events. For hikes, snowshoes:

Class A - Shorter, less strenuous activity, typically 4 to 8 miles, less than 1500 feet elevation gain.

Class B - Moderate to difficult, typically 6 to 12 miles, up to 3000 feet of elevation gain.

Class C - Long and difficult, strong experienced participants only, typically over 8 miles, and over 3000 feet of elevation gain. Boots are recommended for B/C hikes.

Harsh or unusual conditions may greatly increase the exertion and skill required. Be prepared for the level of activity you are planning to take. Contact the trip leader if you have any questions and to let him or her know that you will be attending. Bring plenty of water and a sack lunch. Please, no alcohol. Remember to bring your Ten Essentials. Pets allowed on designated trips only.

Stay with the group and follow the leader. The leader is responsible for the group's safety. The leader determines which route is taken. The leader has authority to determine if a participant is prepared for the activity. Group safety must come first.

Fees

There is no charge to Trails Club members for day activities; nonmembers pay \$2. Please contribute to any carpooling expenses at the rate of \$.15 per mile. With multiple riders the driver can collect up to \$.30 per mile shared by all the riders. Other fees may apply. If you have RSVP'd for an activity at a lodge involving food expense and are unable to participate, you are obligated to do one of the following: Cancel before the food is purchased, find someone to take your place, or pay for your share of the food.

All activities must be approved by the appropriate activity Coordinator or the Trips Trustee.
